

CONEXPO Latin America 2019 & CONEXPO-CON/AGG 2020 Free Air Ticket SWEEPSTAKES  
Official Rules - **NO PURCHASE NECESSARY**

1. SPONSOR: Association of Equipment Manufacturers, 6737 W. Washington Street, Suite 2400, Milwaukee, WI 53214 ("AEM").
2. HOW TO ENTER: An eligible entrant must visit AEM website [conexpoconagg.com/Vegas](http://conexpoconagg.com/Vegas) or [tradeshows.aem.org/acton/form/12770/008c:d-0001/0/-/-/-/index.htm](http://tradeshows.aem.org/acton/form/12770/008c:d-0001/0/-/-/-/index.htm) to complete the simply entry form for the sweepstakes. Only one entry per person. **NO PURCHASE NECESSARY.**
3. ELIGIBILITY: Anyone who, at the time of entering the drawing for the sweepstake, is a national of an eligible participating country, a U.S. citizen or permanent resident and is eighteen years of age or older. Employees of AEM, its promotion and advertising agencies, independent contractors and anyone involved in the development or execution of the Sweepstakes and the immediate families (defined as spouse, parents, siblings, children and their spouses) of such persons and the members of the households of such persons, are ineligible.
4. PRIZE: Air travel for a round-trip, economy class airline ticket to Las Vegas, Nevada, USA or Santiago, Chile (traveler's choice).
